No. GAG(B) 870/87/101.—The Governor of Assam is for administrative expediency, pleased to sanction the formation of a new administrative district to be known as the district of Dhemaji comprising the area shown in the schedule below out of the district of Lakhimpur with its temporary Headquarters at Dhemaji.

Myadi Villages of Pub-Machkhowna G. P. of Machkhowna Mouza).
2. Jonai Sub-Division (whole area).
