1. Candidates must be an Indian citizen as defined in Article 5 to 8 of the Constitution.
2. Candidates must have registered their names in the Employment Exchange and Registration number along with date must be mentioned in their application.
3. Candidates serving in Govt. Department should submit their application through proper channel.
4. If any candidate is found to have suppressed his educational qualifications or given wrong information at the time of applying for job or later on, his candidature shall stand rejected without any information to him with immediate effect and also shall be liable to Criminal Prosecution as per law.
5. Candidates must not be less than 18 years or more than 40 years of age as on 01.01.2023. The relaxation of age shall be applicable as per Government rules.
