The meeting was presided over by Shri Bhaskar Das, ACS, District Development Commissioner, Bongaigaon. At the outset, the Chairman welcomed all the members present in the meeting. Initiating the meeting the District Development Commissioner requested all HODs to coordinate with each other for implementation of the schemes.
