

MINUTES OF THE DDC MEETING HELD ON 22nd JULY/2022 AT 3.00 PM IN THE CONFERENCE HALL OF D.C. OFFICE, BONGAIGAON.

The meeting was presided over by Sri Bhaskar Das, ACS, District Development Commissioner, Bongaigaon.

Member present as per Annexure - I.

At the outset, the Chairman welcomed all the members present in the meeting. Before reviewing the progress of works under different departments, the District Development Commissioner informed the house about two important programme i.e **Chief Minister's Institutional Plantation Programme** and **Har Ghar Tiranga**.

➤ **Chief Minister's Institutional Plantation Programme(CMIPP)** : The Chairman informed about the programme outline:

- i) Plantation drive to be done in Government institutional premises.
- ii) Government official will adopt the plants and nurture it for 3 years.
- iii) All teaching staff, non-teaching staff and students of Educational Institutions will be part of CMIPP.
- iv) After plantation Geo-tagged photo to be uploaded in the portal.

The Chairman requested all the HODs to submit action plan as per format already provided to them indicating nos of sapling and area to be covered and requested to register in the portal: www.shyamaleechouhad.assam.gov.in.

Social Forest and Agriculture deptt will provide saplings as required by different departments.

➤ **Har Ghar Tiranga:** Regarding Har Ghar Tiranga programme the Chairman requested all HODs to instruct their employees including those engaged in contractual basis alongwith all stake holders to host the National Flag from 13th to 15th August, 2022.

On a query from Chair, the DDS, FCS& CA informed that about 1,13,000 Nos flag will be distributed through FPS in Bongaigaon district. Cost of each flag will be Rs.18/- .

SHG of ASRLM will set up sale point at each GP and other important points. Deptt having beneficiary oriented scheme are to create awareness for hoisting National Flag among all beneficiaries.

Thereafter, as directed DFDO, GM, DICC and DVO showed the progress of work through Power-Point-Presentation and the house reviewed the progress of work done by all the deptts and following decisions have been adopted.

1. Fisheries:

- The DFDO, Bongaigaon informed that under PMMSY 2020-21 and 2021-22 construction of new ponds and new rearing ponds had already been completed.
- Distribution of cycle with Ice box, motorcycle with Ice box and e-rickshaw with Ice box had been completed.
- Construction of biofloc yet to be completed. The DFDO was directed to complete the biofloc as soon as possible.

2. Industries:

- On a query from Chair the GM, DICC informed that anyone whose CIBIL score is good may get loan from PMEGP. 372 nos of loans are under process. In this regard, the GM, DICC was directed to arrange awareness camp with PRI members and ULB members.
- GM,DICC informed that 74 Nos. Application of Artisans Card collected from the Bamboo Mat artisans & forwarded to the Office of the Assistant Director Handicraft, Gouripur for Artisan Card.
- 115 Nos. Application of Artisans Card collected from the Pottery Artisans & forwarded to the Office of the Assistant Director Handicraft, Gouripur for Artisan Card.
- Efforts are on for formation of 2 (Two) Co-operative Societies of the Bamboo Mat & Pottery artisans for enabling them for Incentives under Mukhya Mantrir Tholuwa Udyog Bikash Achari (MMTUBA) .
- GM,DICC was directed to include such artisian category in PMJVK scheme.

3. Vety & A.H:

- The DVO, Bongaigaon informed that Re-construction of Chalantapara State Veterinary Dispensary, Chalantapara V.O quarter and water supply system have already been completed.
- Animal Vaccination under National Animal Disease Control Programme(NADCP) is going on . Total animal vaccinated in the 2nd phase (upto 30th June/2022) is 76,050 nos.
- Tagging & issue of animal health cards are continuing & registered in INAPH Portal.
- Artificial Insemination done upto June/2022 : 17,188 nos
- 420 nos of beneficiaries have been selected under NLM for training on Scientific rearing of Pig, Goat and Poultry.
- Beneficiaries also selected for Fodder cultivation,Hand drive chaff cutter and Moringa cultivation.

4. Health Services:

- The Jt Director, Health Services requested all the HODs to direct their subordinate employees to take vaccine (buster dose) immediately, if not taken yet. Also informed that some schools are yet to complete vaccination. Inspector of Schools was requested to inform all the Principals/Head Masters for taking vaccine by the student.
- JDH was directed to check shortage of vaccination.

5. PHE:

- Regarding handing over of PWSS, the EE,PHE informed that 11 nos of PWSS asr ready for handing over. Also informed that all the retrofitting work will be completed by sep/2022.
- The Chairman requested the CEO, ZP, EE PHE and AGM,APDCL to have a meeting by 25/7/2022 for solution of problem regarding electrical bill of PWSS.

- The Chairman expressed his dissatisfaction on the work of Model AWCs in the district. The DSWO was directed to visit the centres in next 3 days.
- ADC and i/c SDO(C), North Salmara was directed to visit AWC at Tinkonia under Tapattary Dev Block.
- The District Development Commissioner, Bongaigaon informed that new building of Bidyapur AWC under Assam Adarsa Gram Yojana completed and directed the DSWO to shift the centre to the new building.
- On a query from Chair , the AGM,APDCL informed that electric connection on 941 AWCs out of 1000 have already been completed and rest 59 nos will be completed soon.




