

MINUTES OF THE DDC MEETING HELD ON 25th Mar/2022 AT 11.00 AM IN THE CONFERENCE HALL OF D.C. OFFICE, BONGAIGAON.

The meeting was presided over by Sri Bhaskar Das, ACS, District Development Commissioner, Bongaigaon.

At the outset, the District Development Commissioner, Bongaigaon welcomed all the members present in the meeting.

The meeting reviewed the minutes of the last DDC meeting and the progress of work of various deptt. After threadbare discussion following decisions/resolutions were adopted.

1. PWD(bldg):

- EE, PWD(Bldg) informed that the progress of work of Model school at Piradhara, Tapattary Block is 78%.
- Progress of Construction of Mini Stadium and Tennis Playground at Abhayapuri is 65%.
- Piling work of the Development of the Stadium at North Bongaigaon under CIDF is going on.
- Progress of Construction of the New Engineering College at Bongaigaon is only 17.3 % . Also informed that progress is slow because of a natural rock found below the building area. The EE, PWD(Bldg), Bajali-Bongaigaon Divn was directed to consult with the consultant concerned to resolve the problem.
- Progress of Museum for the preservation of the culture of Koch-Rajbansi at Bongaigaon under CIDF is 50%

2. Social Forest:

- As resolved in the last meeting, the estimate for the "Miyawaki" forest (a form of forestation) in the Bongaigaon district is yet to be submitted. The District Development Commissioner directed the DFO to submit the estimate to Deputy Commissioner for taking the necessary steps.

3. Soil Conservation:

- On a query from the Chair, the D. O, Soil Conservation informed that one project of WDC-PMKSY(IWMP) for the year Rs.800.2896 has been sanctioned by Gov. DPR preparation and committee formation process is going on.

4. Handloom & Textile:

- Supdt. H & T, Abhayapuri informed that 3565 nos Yarn passbooks have been issued to weavers in the district till date.
- Regarding Mudra Loan, the Supdt. H & T, Abhayapuri informed that 94 nos of loan proposals under MUDRA Loan submitted to bank branches and survey by banks is going on. Once again the Supdt. H & T, Abhayapuri was directed to peruse bank concerned regarding sanction of loan. Also directed to submit the list of lonee to Deputy Commissioner.

5. Sericulture:

- Assist Director, Sericulture informed that som plantation raised on 6-acre land has been done at Nayagaon VGR and 98% Mortality was observed. Also informed that no plantation could be done as sapling & fund yet to receive.

6. Veterinary:

- The DVO, Bongaigaon informed that the Construction of V.O quarter, water supply and state Vety. Dispy at Chalantapara under SOPD has already been completed.
- Regarding vaccination, the DVO informed that vaccination is stopped Round 2 of FMD vaccination will be started in the month of April/22 and Ear Tagging is going on. Progress of Ear Tagging is 42.39%. Uploading is also going on.
- 10 bucks and 100 Rural backyard Goats Under NLM (SCSP) are yet to be distributed among selected beneficiaries.

- On a query from the chair regarding the One Nation One Ration Card(ONORC), the Dy Director of FCS&CA informed that due to technical problems progress of Adhar seeding is slow.
- > However, the progress of Adhar seeding against Ration Card is 85.50% and against beneficiaries is 61.90%.

11. Education:

- > The Inspector of Schools informed that received funds under RMSA against 6 nos of school have already been utilized. 2nd instalment fund is yet to receive.
- > Progress of works construction of ACR, Lab room, Toilet block at Barpathar High School is 96% and that of Malegarh High School is 24% only.
