
Roles of village committee

- Developing the Village Development Plan through Participatory Rural Activities.
- Ensure the geo-tagging of all resources and assets.
- Finalization of the Village Development plans and placing the same in the Gram Sabha for approval.
- Placing the Village Development Plan in the District Level Committee for approval.
- Setting up of Local Construction Committees for works up to 10 lakhs based on the approval of the District Level Committee.
- Assessing the work done by the Village Fellow and providing necessary support.
- Monitoring the projects executed in the village.
- Ensure all works executed in the village are geo-tagged (Both for physical and financial verification).
- Approval of all Construction Committee bills by the Chairperson of the Committee and placed with DC for release of funds.


